### There are four categories of technician certification:

**Type I** - Persons who maintain, service, or repair small appliances must be certified as Type I technicians.

**Type II** - Persons who maintain, service, repair, or dispose of high or very high-pressure appliances, except small appliances and motor vehicle air conditioning systems, must be certified as Type II technicians.

**Type III** - Persons who maintain, service, repair, or dispose of low- pressure appliances must be certified as Type III technicians.

**Universal** - Persons who maintain, service, or repair both low- and high- pressure equipment, as well as small appliances, must be certified as Universal technicians.
